## **Troop Checking/Savings Account Transitions for Girl Scouts of Western Ohio**

As the merger date of January 1, 2008 has passed, all troop checking accounts will need to be changed to reflect the new council name of Girl Scouts of Western Ohio as well as the new council ID number. For opening up a new troop checking account, the following standards are in place:

- All troops/groups must have a bank account with the signatures of TWO registered, non-related adults for withdrawal or check writing purposes.
- The account information should read as follows:
  - **Girl Scouts WO Troop # \_\_\_\_\_**
  - **Girl Scout ID Number: 31-0679091.**
- Please follow current regional office procedures in filing bank's opening papers with the council.

For those troops with an existing account, please visit your banks to have the account information switched to the above.

Please note: new checks do not need to be ordered. As you deplete your troop checks, please make sure that your new checks would have the correct information on the account.

If you have any problems with this transition, please contact the local finance office at your regional service center.

**The tax exempt form does not have a signature on it as the person using the form should sign the form as it is used.**
